Attainable Homeownership Tax Credit

How it works:

- Who** AHTC is available to all Indiana tax-payers - individuals, couples, businesses, and corporations - in Indiana who make a donation to Habitat for Humanity of Indiana.
- What** These tax credits may be used to offset individual income or business taxes in the tax year the donation is made. Eligible donations include cash, stock, approved land gifts, and approved new construction materials.
- How** The tax credit is equal to 50% of the donation made to Habitat. For example, a gift of \$1000 qualifies you for a \$500 tax credit. There is a cap of \$10,000 in tax credits allowed per tax year (with a \$20,000 donation), but unused credits may be carried over for up to 5 years. If you itemize deductions on your federal return, additional tax savings may be possible!
- Where** Donations must be made to Habitat for Humanity of Indiana in order to process your credits. All donations will be distributed to our local affiliate, as long as you indicate "Habitat for Humanity of Monroe County" on your Donor Contribution Form.
- Donate** Gifts must be sent with a Tax Credit Form! Scan the QR code below or visit monroecountyhabitat.org/AHTC to learn more and access the form.
